

## **Name That Fog Contest Official Rules**

The Name That Fog Contest is a contest organized and run by the Rotary Club of Pacifica (Club), with all proceeds being devoted to purchasing dictionaries for all third-grade students in the city of Pacifica, CA, and other Rotary projects. The address of the Rotary Club of Pacifica is PO Box 1051, Pacifica, CA 94044.

- 1) This is a contest, open to all legal residents of the United States, over the age of 18.
- 2) This contest is void where not legally allowed.
- 3) By entering this contest the entrant is agreeing to be bound by these Official Rules.
- 4) The venue for this contest will be San Mateo County, California and will follow the laws as they pertain to San Mateo County, California.
- 5) All winners agree to allow Club to use their names and/or likenesses for publicity for the Club and the Club projects that are made possible by this contest. Contestant retains the rights to their submitted entries. The Contestant allows the Club to use their submitted entries for promotional and other purposes.
- 6) There is no purchase required, however an entrance fee of \$10.00 for each contest name submitted, 3 contest names for \$25.00 is required. Entries received without an entrance fee will not be judged.
- 7) Contestant certifies that submitted entries do not contain any copyrighted or trademarked terms. Contestant assumes all liability for their submitted entries
- 8) If duplicate entries are received, the first identical entry received will be judged. No refunds will be given for duplicate names.
- 9) Judging will be done by a panel of five (5) local celebrities. All decisions are final. Correspondence regarding the judging will not be entered into.
- 10) The contest begins at noon on July 30, 2013 and ends at 5PM Pacific Standard Time on October 20, 2013.
- 11) The Rotary Club of Pacifica is not responsible for any entries not received for any reason.
- 12) Winners will be announced the evening of October 27, 2013 at the Rotary Club of Pacifica Bowlathon in Pacifica, Ca.
- 13) All winners will also be notified by a phone call, email or First Class US Mail postmarked no later than November 4, 2013.
