Credit Cards: Online via www.rotary.org – must be authorized on or prior to 31 December 2012, midnight (Central Standard Time); or by **Fax:** (847-328-4101)/**Phone:** (866-976-8279)- must be received prior to the close of business on 31 December 2012.

Mail (least preferred): Sending credit card information by mail is less secure and slower than contributing on-line. If submitting credit card

contributions by mail it must be postmarked by 31 December 2012 and received by the Foundation by 8 January 2013: **The Rotary Foundation, 14280 Collections Center Drive, Chicago, IL 60603**

Five tips for increasing your Club's Foundation giving

Hours: Monday through Friday from 8 a.m. to 5 p.m. Central Time

Over the past four years, the Rotary Club of Honolulu Sunset, Hawaii, USA, has averaged \$803 in per capita giving. District Annual Giving Subcommittee Chair Richard Zegar offers his top tips for increasing your club's giving:

- 1. Select committed Rotarians to serve in fundraising positions for several years in a row. This consistency contributes to an "atmosphere of giving."
- 2. Meet one-on-one with members to discuss The Rotary Foundation's work. Then ask them to join you in supporting the Foundation.
- 3. Recognize new members by making donations to the Foundation in their names. Not only will you introduce them to <u>individual recognition</u> opportunities, but you'll also encourage their continued support.
- 4. Use <u>Foundation reports</u> to inform members of their current recognition levels and encourage them to reach the next level. Acknowledge club members who attain higher giving levels.
- 5. Explain how effective and efficient The Rotary Foundation is compared with other charities. For example, tell members that 100 percent of their donations fund programs.

Major Gifts to the Foundation

We are often asked if there is a way to support The Rotary Foundation other than cash. Rotarians can give gifts of personal property, stocks and bonds, and real property and receive a charitable taxable deduction. Please read further to understand the opportunities that are available.

Tangible personal property

Gifts of tangible personal property, such as jewelry or artwork, are given careful consideration on a case-by-case basis.

The Rotary Foundation's general guidelines specify that gifts of jewelry be worth at least US\$10,000 and gifts of artwork be valued at a minimum of \$25,000. Gifts must also be accompanied by a written proposal, which must include a qualified appraisal, photograph, and supporting materials, such as authentication papers. If you're interested in making a gift of tangible personal property, contact the Gift Administration department. Contributing appreciated securities to The Rotary Foundation may benefit you in two ways:

- You may avoid paying capital gains taxes
- You may receive a charitable tax deduction

Stocks and mutual funds can be transferred either electronically or by mail. Detailed instructions are available for residents of the United States and Canada. Do not mail stock certificates to the Foundation's post office box. If you are donating U.S. stock or U.S. mutual funds, complete a Publicly Traded Securities form with your gift. If you are donating Canadian stock, please follow the Canadian stock instructions. If you are sending certificates via mail, you'll also need to complete a stock power form to assign ownership to the Foundation. For additional information on making a gift of stock, or if you're interested in contributing mutual funds, bonds, or closely held securities, read the Publicly Traded Securities brochure, or contact the Gift Administration department.

Real estate

Making a gift of real estate to the Foundation may afford you financial benefits. Consult your financial adviser about your personal circumstances.

To initiate the process, you must obtain an independent qualified appraisal of the property. The property's value should be at least \$100,000 (or \$25,000 for undeveloped land) if you wish to make an outright gift to the Foundation. If you're interested in funding a charitable remainder trust, the property should be worth at least \$100,000.

If you believe that a gift of real estate could benefit you and the Foundation, contact the Gift Administration department.

"Foundation Month" Report for D-5170!

As shown on the table on the next page, this month's report for our District looks very exciting, and shows the great effort that many of our clubs have put forth. We have five clubs which have already exceeded their Annual Goal: Almaden Valley, FUN, Mt. View, STAR, and Sunnyvale. Two other clubs are over the \$200 per member mark: Almaden Valley and Mt. View. Fifteen clubs are well on their way with over \$100 per capita, a great effort. We also have clubs that are getting close to 100% EREY, with the following clubs are leading the way: Mt. View (88.2%), Almaden Valley (71.4%), and San Jose East/Evergreen (61.9%). In fact, some clubs are well on their way to achieving the "triple-play" of 100% Goal, Double-Sustainer Per Capita, and 100% EREY. This will be outstanding! While we are ahead of last year's pace, we still have a long way to go. So where is your club? Check out the Annual Giving Report and compare!



The Rotary Foundation has announced the award of a 2013 Rotary Peace Fellowship to Lauren Markham, a writer and educator sponsored by the Rotary Club of Oakland #3. The notification letter to Lauren read, in part:

On behalf of the Trustees of The Rotary Foundation, we are pleased to inform you that you have been selected to receive a 2013 Rotary Peace Fellowship for studies as part of the Rotary Peace Centers for International Studies in peace and conflict resolution program. You have been assigned to the Rotary Peace Center at Chulalongkorn University in Bangkok, Thailand, to attend the winter session, which will occur 12 June – 30 August 2013.

Lauren is a writer, educator and refugee advocate who lives in Oakland, California.

Lauren writes fiction and essays and was recently named a 2011 Middlebury Fellow in Environmental Journalism. In addition to supporting refugees in the Bay Area, Lauren has worked with marginalized communities around the world using storytelling as a vehicle for learning and growth. Lauren studied Literature and Political Science at Middlebury College and has an MFA in Creative Writing from Vermont College of Fine Arts. She is currently earning her Single Subject Teaching Credential from the Bay Area Teachers' Center, while she works in the Oakland Public School District. She is pictured at the right working recently at a leadership camp in El Salvador with the organization Asociacion Pro Salud Rural (ASAPROSAR), which serves thousands of Salvadorans every year through water and sanitation programs, early childhood health outreach, vaccination and eye clinics, and youth services.
